The policy is for the driver to call into dispatch to get directions. The system is going to be upgrade will take place next Thursday. Additionally, the maps are updated every 12 months.

Mona asked if the service for Access or Dial a Ride will increase their drivers and vehicles to meet the increase in population of elderly/disable passengers.

Ben responded by stating that the ridership is always being reviewed. Additionally, denials are very few, close to none. When there is an increase, the Transit division will go through the budget process to have these accommodations approved. The same goes for Local and Commuter routes; this is assessed every 6 months.
